Many thanks to everyone who weighed in our Neighborhood Council Fiscal Year Survey. We'll reviewing all the feedback and will be making changes, so we can support Neighborhood Council better this year. Thanks, as well to those Neighborhood Councils who have completed their self-assessment survey. It's great to look back and document the successes of your Council as well as learn where improvements can be made. We're looking forward to the official certification of at least one of our two subdivided new Neighborhood Councils this month. The Board of Neighborhood Commissioners have a full schedule with their regular meetings and special town halls this month on the Neighborhood Council reforms, but we are hoping to schedule the certification hearing for North Westwood Neighborhood Council at the end of the month. The Historic Cultural North Neighborhood Council will likely be scheduled in the beginning of September. So, by September 22, 2018, we'll be celebrating the Congress of Neighborhoods with 99 Neighborhood Councils. The Planning Committee for the Congress of Neighborhoods will be meeting regularly in August to finalize the big day so if you can lend a hand, please join them. ## Funding Updates:

As mentioned in last month's profile, the new/revised NC Funding Program Policies & Guidelines version, dated July 1, 2018, is now posted on our website ([clerk.lacity.org](http://clerk.lacity.org)) for your review, comments and questions. Please review the policies to stay up to date with revisions or additions made which have been highlighted for your convenience. Also, if your Neighborhood Council has received special account funds, the accounts can now be viewed via our NC Funding Portal. Through the Funding Portal, you are now able to make requests for payments from the special account funds, as applicable, as well as see the transactions and balances for the accounts. Thank you to all those NCs that have submitted their 2018-19 Fiscal Administrative Packet. Please be reminded that we need your budget in place, along with the Administrative Summary Packet, to release all funds at the start of the year. If we don't receive your budget, we will make

\$333 available for up to 3 months for preparations for a meeting. Our training/education sessions have resumed in the new Fiscal Year. please refer to our website for additional information and to RSVP for any training/education session.

## Field Updates:

This month, our Neighborhood Empowerment Advocates (NEA) will be sending over an updated map created by our partners at the City Clerk's Office. The City Clerk's Elections Division have been working with the Department to create maps that are more detailed based on the boundary descriptions under Article III of your NC's bylaws. Over the summer, the Department has been reviewing maps, boundaries and bylaws and have found areas where administrative corrections are needed. To ensure there is no overlap and to effectuate the intent of your NC's boundaries, but most importantly, to gear up for the 2019 NC Elections, your NCA will be sending over your NC's bylaws with the new maps and in some cases, with corrected boundary descriptions. Please review your bylaws and if you have any questions about these corrections, please reach out to [NCSupport@lacity.org](mailto:NCSupport@lacity.org) no later than Wednesday, August 15 so that we can be of assistance.

On another note, we say goodbye to our Civic Youth cohort of 40+ students this summer but EmpowerLA will be offering its second cohort of IgniteLA, a program geared toward young women that builds civic knowledge and leadership skills to bolster civic engagement. For three months on Monday evenings from September 2018 through November 2018 from 5:00pm -7:30pm., our staff will be leading IgniteLA cohorts across the City.

## Outreach Updates:

The Department is in Phase 1 of our Citywide Outreach Plan- Awareness. In this phase new partnerships have been formed to help spread word of the NC System. For the system to grow, we believe relationships and collaboration is a must. We are excited to be working with Global Shapers, a group of inspirational millennials dedicated to creating an impact-generating project that would better their local community. One project they committed to was sending a survey to their database that asked how they engage Neighborhood Councils. They will be partnering with us also on providing support for social media and design. Another group we partnered with is the Council District 9 Coalition. This Coalition brings together many non-profits from Council District 9 to discuss like-minded issues. We have been able to speak at a few of their Get Out to Vote youth workshops and had youths committed to learning more about Neighborhood Councils. A youth alliance in South LA may be underway. Lastly, we are excited to have brought on a few temporary staff to support our outreach efforts. We have completed our Regional Gatherings in which outreach leaders from each NC had an opportunity to learn on a regional level...the how to's of outreach. On August 20th, we will be convening a gathering of neighborhood leaders, non-profits, business owners, and academics from across the City to inform them about Neighborhood Councils and how they can get involved in the 2019 elections. In September, we will be holding our 2nd Citywide Outreach Chair gathering.

## Policy Updates:

At upcoming Board of Neighborhood Commissioners meetings in August, there will be an agenda item providing an opportunity to provide feedback and input on the definition of a community interest stakeholder. In addition, the Board of Neighborhood Commissioners is also seeking public input on Neighborhood Council System Reforms as proposed in Council File 18-0467. Please join us at a future meeting to provide your input and feedback. The next Board of Neighborhood Commissioners meeting will be on Tuesday, August 7 at 6 pm at the Boyle Heights Technology Center located at 2130 East 1st Street, LA, CA 90033. There will also be a Board of Neighborhood Commissioners meeting on Monday, August 20 at 1 pm at Room 1050 of City Hall. There will be a special meeting of the Board of Neighborhood Commissioners on Wednesday, August 15 at 6 pm at New Open World Academy located at 3201 W 8th St, Los Angeles, CA 90005 in the Koreatown community.

To vote on Neighborhood Council funding items, Neighborhood Council board members must have current ethics training and funding training. The Neighborhood Council bylaws may also require these trainings to vote for nonfunding items as well. To serve on a board, Neighborhood Council board members must also have either read and signed a Code of Conduct or have watched the video. To complete these trainings, please click [here](#).

**NOTE:** in person and online ethics training must be a minimum of 2 hours. If you complete the ethics training online, please ensure that you take 2 hours to complete the training as we will not accept any certificates that show less than 2 hours.

### Board Members who have not completed the Funding training:

Funding - Eligibility to Vote on Financial Matters a. To be eligible to vote on any NC Expenditure, Financial Reports, and/or annual budgets, the board member must:

- Be an Elected, Appointed and/or Selected Board Member of the NC
- Be 18 years of age or older
- Have completed the California State Ethics Training Requirement for Local Officials (AB 1234)
- Have completed the online NC Board Member Funding Training and obtain a passing score of 70% on any test associated with the online course.

### Board Members with missing or expired Ethics Certificates:

ETHICS - All Board Members are bound by California State Law to take Ethics Training every two years. Take the online course, and send your certificate to [Rosters@EmpowerLA.org](mailto:Rosters@EmpowerLA.org). Ethics Training is a required for all Board Members
